### Preamble and the Purpose of the Understanding:

This Memorandum of Understanding (MOU) signed on the 7<sup>th</sup> of January, 2020, between two parties; one officially representing as the Teacher-in-Charge of 'Samuktala Sidhu Kanhu College' (College) and the other as the President of the 'East Indian Society for the Studies of Social Sciences' is made effective for a period of 5 years from the date of its signing i.e. 7<sup>th</sup> of January, 2020 to 6<sup>th</sup> January, 2025, for the purpose of Research Works on Social Science and Humanities.

The Memorandum of Understanding (MOU) for the aforementioned purpose is signed between Sri. Ranjit Biswas, S/O Akhil Chandra Biswas, aged about 36 years, a Hindu by faith, residing at Dakshin Nararthali, Kamakhyaaguri, Alipurduar-736202,

hereinafter referred to as the FIRST PARTY officially representing as the Teacher-in-Charge of Samuktala Sidhu Kanhu College, Alipurduar, a West Bengal Government-Aided undergraduate degree College with its office at P.O.- Taleswarguri, District- Alipurduar, West Bengal, 736206, affiliated to the University of North Bengal.

Dr. Sulekha Pandit, W/O Dr. Saiten Debnath, aged about 60 years, a Hindu by faith, residing at Purbachal, 2nd Bye-Lane, Court Complex, Ward No -1, P.O. Alipurduar Court, P.S - Dist. Alipurduar, PIN: 736122, hereinafter referred to as the SECOND PARTY officially representing as the President of the East Indian Society for the Studies of Social Sciences. [Reg. No S/IL/79269 (2011-2012)] with its office at Purbachal, 2nd Bye- Lane, Court Complex, Ward No -1, P.O. Alipurduar Court, P.S - Dist. Alipurduar, PIN-736122, West Bengal, India

Whereas, to give effect to the sole purpose of research as aforementioned, the FIRST PARTY approached the SECOND PARTY expressing the desire of making a periodic understanding for a particular duration of time, the SECOND PARTY being greatly interested responded very positively; and the confluence of their mutual interests in research and publication inevitably paved the path to the signing of the present understanding (MOU).

**Stipulations**

Samuktala Sidhu Kanhu College and the East Indian Society for the Studies of Social Sciences academically share numerous common objectives and interests aimed at enhancing researches in the domains of social sciences and humanities; therefore, there are considerable advantages to be gained from purposive mutual collaborations between the two institutions.

Naturally, the two institutions, viz. Samuktala Sidhu Kanhu College and East Indian Society for the Studies of Social Sciences, have decided to enter into this Memorandum of Understanding (hereinafter referred to as MOU), which defines the framework for cooperation between the two institutions in the following sections.

1. Samuktala Sidhu Kanhu College and the East Indian Society for the Studies of Social Sciences mutually agree to collaborate with each other in matters of organizing seminars, symposiums and talks on topics relating to original and basic researches in the domains of social sciences and humanities.
2. Both the institutions agree to be involved in publications of research-oriented papers in the forms of journals, anthologies and magazines whenever occasions arise on attaining consensus by both the sides on matters of responsibilities financial or intellectual or otherwise in nature.
3. Both the institutions agree to transmit to each other informations relevant to researches as earmarked above; and that to effect of increasing the treasure of knowledge in the said fields of research and publications.
